4. Capture your name in the case of an individual or corporate name in the case of a legal entity.
5. Some data relating to your business or activity;
6. An email where you can receive messages; and,
7. Attach proof of tax situation in *PDF format* containing proof of Tax Situation with QR Code.

The interested parties must express their interest by using the option "Participate" in the tender with the status of "Effective", in the public portal of *Compranet B.C.S.*, in the period from **July 7 to 18, 2023**.
